#### Safeguarding Training:

All volunteers who are crewing on our vessels need to have undertaken safeguarding training. Once completed you can download your certificate and email it to the Challenge Wales office. This training can be done anytime from before you submit your volunteer form to having your induction. It is free of charge.

The safeguarding training is Group A training delivered online by Social Care Wales and complies with current legislation. How we use your data: We use your data to process your volunteer form and we don't share it with any other parties. For your DBS background check you will complete a separate application form which is submitted via the Association of Sail Training Organisations and the Royal Yachting Association which they will see to undertake the DBS. We will communicate to you via email as this is the most cost effective way for us to contact you. Filling in your email address indicates that you are happy for Challenge Wales to add you to our volunteer email list (once you are a volunteer) and our general mailing list while you are going through the volunteer process. You can unsubscribe from this at any time however, this will mean you won't get any information about volunteering. Your details will not be passed on to any third parties without your permission. The only third party we deal with is for DBS background checking as mentioned above.

#### Section 5: Declaration

For those applying to be volunteer crew: A Volunteer Form should be ideally submitted prior to joining a voyage so that an assessment can take place when you sail with us. If you complete a Volunteer Form after a voyage, and haven't been recommended by the Skipper to apply, then the Volunteer Form must be sent back to us as soon as possible after a voyage and within 3 months of sailing with us, so that we can complete a volunteer assessment form as accurately as we can. Outside of this timeframe, you may/will be asked to join us for an additional sailing voyage, at a nominal cost, to be assessed. All volunteer crew will have a probation period.

I understand and agree that before qualifying as crew, I must pay for a volunteer qualifying assessment voyage (minimum of 1 day), attend a Volunteer Induction Session and that to keep my volunteer crew status, I must take part in at least two volunteer crew training days and at least one voyage (of one day or longer) within 12 months of my volunteer qualifying voyage on Challenge Wales and every 12 months thereafter. Should I not be able to sail within 12 months, I understand I will need to pay for another one day assessment voyage. I will also read the policies and procedures document (which is onboard Challenge Wales, at the Challenge Wales office or online) which can be accessed when a volunteer.

For all volunteers: By this declaration, I acknowledge that my participation in the activity of Challenge Wales is entirely voluntary and I understand that if I am unsuccessful in my application to become a volunteer that I will be advised accordingly. I also understand that my participation in the activities of the charity may involve risk of harm, with knowledge of the risks involved, I voluntary consent to participate in the activities and agree to assume any and all risks of injury, damage or death from my participation. I further release and discharge Challenge Wales, its agents, servants, employees, or representatives from all actions, claims, or demands that I, my heirs, guardians, legal representatives or assignees now have or may hereafter have for injury, damage or death resulting from my participation in the activity. By being a volunteer I agree to uphold Challenge Wales' values and code of conduct which will be shared with me once I am a volunteer. Should I decide to stop volunteering then I will advise Challenge Wales straight away to avoid the charity incurring costs for keeping my volunteer status open.
